Under this program, well trained, independent midwives are employed under different models in different geographical location and will be called MS Ladies. MS Ladies will offer all five modern family planning methods (STM and LARC) including Medical Abortion Services. Program Officer is expected to mobilise MS Ladies, Youth Mobilizers and Community Based Mobilizers and communicate and coordinate at the Provincial/district/ Municipalities level and ensure that MS Ladies reports, documents and other records are maintained and are forwarded to Support Office on time.
