#### **1. Introduction and Organizational overview**

##### **Sunaulo Parivar Nepal (SPN)**

Sunaulo Parivar Nepal (SPN) is a well-established NGO delivering Family Planning and Sexual Reproductive Health services through-out Nepal via different service delivery channels: centers, outreach, and Marie Stopes (MS) Ladies.

Sunaulo Parivar Nepal, Support Office invites sealed bids for the supply and delivery of the USG Machine as per Model Technical Specification (attached).

#### **2. Objective**

SPN provides family planning and other sexual and reproductive health (SRH) services to over 184,000 clients a year over 50 districts in Nepal through a variety of service delivery channels that include a network of static clinic centres, mobile outreach teams, MS Ladies (nurse entrepreneurs), and a commercial sales channel. As a member of the MSI global partnership, SPN can use the MSI global brand and its clinics work under the title 'Marie Stopes Center.'

SPN is seeking to procure USG Machine for increasing access to high quality reproductive health information and services for the underserved, including youth, the poor and rural women.

### **3. Language**

All bids should be submitted in English.

The contract and all future correspondence will be in English.

### **4. Contract terms**

The Framework Agreement/Contract (FA) will be valid from the date contract signing till successful completion of supply, delivery and installation of USG Machine for Marie Stopes Centres and confirmation from the organization.

The contract will be a supply agreement for the period stated above.

### **5. The Goods/Services required**

### **6. Specifications**

**Use-** The machine with this specification can be used for many conditions related to gynecology, obstetrics, urology, abdomen and cardiology.

Some common uses in our MSI service sites are-

1. To determine the gestational size.
2. To scan pelvis and abdomen to know any abnormalities including PID, ectopic pregnancy, uterine perforation, peritonitis and any other anomalies.
3. To assess the health of the mother and fetus in pregnant woman.
4. To determine the status of missing implant and IUD.
5. Have additional features to scan other body parts for Thyroid & parathyroid, scrotus, gall bladder etc.

## 13. Opening of Bid

## 14. Bid Evaluation Criteria

### 14.1 Essential criteria

- Bidder's registration in Nepal, submit copies of company registration, Vat Registration, latest tax clearance, quality assurance certificate and guaranty/warranty if any.
- Bidder meets the required specification for the product: quality and certification as mentioned in annex 6.
- Bidder's must confirm and sign all the bidding documents along with attached supplier questionnaire and code of conduct.

### 14.2. Weightage of the bid evaluation criteria:

The evaluation criteria are scored as follows:

Only bids that have met and received approval for the required technical specifications shall proceed to the evaluation stage, where their evaluation scores will be assessed in accordance with the criteria outlined below:
